# Official Rules

## Colorado Teams Summer Snapshot Contest

**NO PURCHASE NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited or otherwise restricted by law.**

This Sweepstakes is open to legal residents of the 50 United States or D.C. Void in Puerto Rico and everywhere else outside the U.S. and where prohibited, or otherwise restricted by law. Subject to all federal, state and local laws. By entering the Sweepstakes, entrants are bound by and agree to these official rules.

The Colorado Team Summer Snapshot Contest ("Sweepstakes") begins at 12:05 AM MST on Tuesday, June 10, 2010 and ends at 11:55 PM MST on Saturday, July 31, 2010 ("Promotion Period").

### **1. HOW TO ENTER:**

**ONLINE:** Log onto [www.colosports.org](http://www.colosports.org), go to the Contests & Giveaway page and click on the Colorado Team Summer Snapshot Contest. Send us your "Team Photo" via [info@colosports.org](mailto:info@colosports.org) or by clicking the "Enter Now" link. Photos must be accompanied by your name, age, valid email address, telephone or mobile phone number during the Promotion Period (June 10, 2010 through July 31, 2010). No limit to amount of entries per person/team. All eligible entries must be received no later than 11:55 PM MST on Saturday, July 31, 2010. All entries become the sole property of Colorado Sports Organization, LLC, and will not be acknowledged or returned. Incomplete entries are void. Any individual who attempts or otherwise encourages, directly or indirectly, the entry of multiple or false contact information under multiple identities, or, multiple or false entries, as determined by the Sweepstakes Entities, will be disqualified. If you send your entry online, prize will be awarded to the name on the online entry form. In the event of a dispute as to the identity of an entrant, entry will be declared made by the authorized account holder submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to the email address by an Internet access provider, Internet service provider or other organization (e.g. business, educational, institution, etc.) that is responsible for assigning email addresses. In the event of a dispute as to the identity of an entrant, the potential winner may need to present a bill to confirm his/her status as the authorized account holder of the account used to submit the winning entry.

**2. Photos:** All photos must be in jpg. format and no larger than 250 kb. Photos must show 4 or more “athletes/teammates” to be eligible for prizes.

**3. Random Drawings/Notification:** One random drawing will be conducted every 7 to 14 days from all eligible entries received for the sweepstakes. Prize drawings will be conducted by Colorado Sports Organization, LLC whose decisions shall be final and binding, as the administrator of the Sweepstakes. The winner will be notified by telephone, email. The winner must respond to such notification within 7 days after the notification is sent or an alternate winner may be selected from the remaining eligible entries. Upon prize forfeiture, no compensation will be given.

**4. Prizes:** One winner will receive the Grand Prize, a team sponsorship (up to \$250) paid by the Colorado Sports Organization on or before December 31, 2010. All photos entered will be eligible for the Grand Prize. The winner will be chosen by Colorado Sports Organization officers. Other weekly prizes will be awarded at the discretion of the Colorado Sports Organization, LLC.

All prize winners may be required to complete, sign and return an Affidavit of Eligibility/Liability and Publicity Release (where permitted by law) as well as any other documents which may be required by Sponsor or prize provider, all of which must be received fully-executed within 7 days of date printed on notification or he/she may be disqualified and prize may be forfeited and awarded to an alternate.
